What is Cookie?

Cookies are files exchanged between a user's computer and a web server that contain small pieces of data, such as usernames and passwords, used to identify specific users and enhance their browsing experience. Cookies allow for a more efficient operation of a website, as well as to enable the provision of personalized pages to offer a more tailored and faster browsing experience that aligns with your personal preferences. Cookies only contain information about your browsing history on the internet and do not collect any information about files stored on your computer or mobile device.

Cookie Types and Intended Uses

There are two types of cookies based on their validity periods: "Persistent Cookies" and "Session Cookies". Session cookies are created when you visit the website and are only valid until you close your browser. Persistent cookies, on the other hand, are created when you visit the website and remain valid until you delete them or until their expiration date. Persistent cookies are used for processes such as providing a personalized experience that is in line with your settings.



According to the purposes of use, the types of cookies and their purposes of use are described below:

ESSENTIAL COOKIES	Essential cookies are cookies that are necessary for the functioning of the website. If essential cookies are blocked, certain parts of the website may not work. These cookies enable security enhancements, remember searches, and allow for functions such as logging in, but they are not used for marketing activities.
COOKIES REQUIRED FOR FUNCTIONALITY	Functional cookies allow website content to be personalized for users based on their preferences when visiting the website. These cookies are used to provide functionalities other than essential cookies. In cases where it is not clear that the data subject has explicitly requested an information society service, explicit consent will be required.
COOKIES REQUIRED FOR PERFORMANCE AND ANALYSIS	These are cookies that enable the statistical measurement of user behavior for the purpose of analyzing it on websites. It collects the information on how the site is used, such as how and for how long, with the aim of enhancing the user experience.

Which Cookies Are Used for What Purposes?

As TP-OTC, we use cookies on our website and in our application for various purposes, and through these cookies, we process personal data. These purposes are mainly as follows:

pll_language	1 year	This cookie is set by the Polylang plugin for WordPress-supported websites. Cookies are stores the language code of the last visited page.



How Can You Control the Use of Cookies?

You can delete cookies or prevent them from being saved/placed through the settings section of your internet browser on your computer or mobile device. If you choose to delete cookies, your preferences on the respective website will also be deleted. If you prefer to completely block cookies, many websites and digital platforms, including those owned by TP-OTC, may not function properly.
